1 【提出理由】

当社は、当社の4.20%非累積的優先株式シリーズMMの募集を報告するため、金融商品取引法第24条の5第4項及び第15項並びに企業内容等の開示に関する内閣府令第19条第1項及び第2項第1号の規定に基づき、以下のとおり本外国会社臨時報告書を提出いたします。

For the convenience of the Japanese readers, the amounts presented in Japanese Yen in this report were translated at the exchange rate of Japanese Yen (JPY) 110.25 to 1 U.S. Dollar (\$), the mean of the telegraphic transfer selling and buying exchange rates vis-à-vis customers on MUFG Bank, Ltd. on July 27, 2021. In some parts of this document, the figures in Japanese Yen have been rounded in millions. Such conversion should not be construed as a representation that any amounts represent, or have been or could be converted into, Japanese yen at that or any other rate.

1. Reason for the Filing of this Report

This Report is being filed by the Company due to issuance of the Company's 4.20% Non-Cumulative Preferred Stock, Series MM,pursuant to Article 24-5, Paragraph 4 and Paragraph 15 of the Financial Instruments and Exchange Law and Article 19, Paragraph 1 and Paragraph 2, Item 1 of the Ordinance of the Cabinet Office Concerning Disclosure of Information of the Companies.

2. Matters to be Reported

The Company will not declare or pay or set aside for payment full dividends on any of our preferred stock ranking as to dividends on a parity with or junior to the Series MM Preferred Stock for any period unless full dividends on the shares of the Series MM Preferred Stock for the most recently completed dividend period have been or contemporaneously are declared and paid (or have been declared and a sum sufficient for the payment thereof has been set aside for such payment). When dividends are not paid in full on the Series MM Preferred Stock and any other series of preferred stock ranking on a parity as to dividends with the Series MM Preferred Stock, all dividends declared and paid upon the shares of the Series MM Preferred Stock and any other series of preferred stock ranking on a parity as to dividends with the Series MM Preferred Stock will be declared and paid pro rata.

So long as any shares of the Series MM Preferred Stock are outstanding, unless full dividends on all outstanding shares of the Series MM Preferred Stock have been declared and paid or a sum sufficient for the payment thereof set aside for such payment in respect of the most recently completed dividend period:

- no dividend (other than a dividend in common stock or in any other capital stock ranking junior to the Series MM Preferred Stock as to dividends and upon liquidation, dissolution or winding-up) will be declared or paid or a sum sufficient for the payment thereof set aside for such payment or other distribution declared or made upon our common stock or upon any other capital stock ranking junior to the Series MM Preferred Stock as to dividends or upon liquidation, dissolution or winding-up, and
- no common stock or other capital stock ranking junior to or on a parity with the Series MM Preferred Stock as to dividends or upon liquidation, dissolution or winding-up will be redeemed, purchased or otherwise acquired for any consideration (or any moneys be paid to or made available for a sinking fund for the redemption of any shares of any such capital stock) by the Company,

subject to certain limited exceptions.

Dividend Payment Dates: Each March 1, June 1, September 1 and December 1, beginning on December 1, 2021, in each case if declared by the Company's board of directors or duly authorized board committee.

Optional Redemption:

On any Dividend Payment Date on or after September 1, 2026, in whole at any time or from time to time in part, or at any time following notice given within 90 days after a "capital treatment event" (subject to certain limitations) in whole but not in part, at a redemption price equal to \$10,000 per share of Series MM Preferred Stock (equivalent to \$ 25 per Depositary Share), plus any declared and unpaid dividends, without accumulation of undeclared dividends.

Voting Rights:

The holders of the Series MM Preferred Stock and of the Depositary Shares will not have voting rights, except as specifically required by applicable law and except as below:

Whenever, at any time or times, dividends on the shares of Series MM Preferred Stock have not been paid for an aggregate of six or more dividend periods whether or not consecutive, the authorized number of the Company's directors will automatically be increased by two and the holders of the Series MM Preferred Stock will have the right, with holders of shares of any other class or series of parity preferred stock outstanding at the time upon which like voting rights have been conferred and are exercisable, which we refer to as "voting parity stock," voting together as a class, to elect two directors, which we refer to as "preferred directors," to fill such newly created directorships at our next annual meeting of stockholders and at each subsequent annual meeting of stockholders until full dividends have been paid on the Series MM Preferred Stock for at least four consecutive dividend periods. At that time such right will terminate, except as expressly provided in the Certificate of Designations or by law, subject to subsequent revesting.

Net proceeds may be temporarily invested pending application for their stated purpose.
